Creating a safe, healthy
community, together.

Since 1976, DVS has supported survivors of domestic violence in Lancaster County with crisis and supportive services. DVS also focuses on community awareness, education, and prevention of domestic violence. Get involved by volunteering, donating, or spreading the word - every action counts!

In 2023, DVS provided support to 2,004 individuals affected by domestic violence, including both victims and survivors.

Counselor/Advocates addressed a total of 1,146 texts and calls received on the hotline.

A total of 16 families, comprising 31 children, currently live at DVS' Bridge House Transition Housing.

A total of 1,200 clients received services from the DVLC, with 360 represented by attorneys and 667 supported during court appearances.
